- 2. Circumstances under which contributions will be invested on your behalf. If you fail to provide investment direction regarding any of your contributions, then the Plan will invest the contribution in a default investment on your behalf. Separate instructions regarding how to direct your investments have been provided. If you have lost or misplaced this information, please contact Alerus to request a new copy.
- 3. **Description of Default Investment.** The Plan uses "Target Date" funds as its default investment option. Target Date funds are managed with an individual's target retirement date in mind. Each fund is designed for individuals who plan to retire close to the year described in the fund and the investment mix becomes progressively more conservative as the target date approaches. If you fail to provide investment direction, the Plan will invest your contributions in a Target Date fund based upon your year of birth as follows:
